Please complete all highlighted fields on the form.

Your state's designated voting member is required to complete and sign the form.

Once you have the completed form, please save an electronic copy for your records. **Print and sign the form.** This is your membership dues invoice.

Submit the original signed form along with your payment to the address on the top of the form. If your payment is mailed by someone other than yourself, (e.g. your finance or accounting division) please ensure that they have the correct mailing address for NASRA.

Voting Designation and Notice of Consent Section:

In accordance with NASRA bylaws, each state is allowed only one vote on matters, and **the vote must be cast by the person designated to vote for that state.**

Minnesota Statute § 317A.453 allows a member to cast or authorize the casting of a vote, but only if an organization's articles of incorporation or bylaws permit proxy voting. Neither NASRA's articles of incorporation nor our bylaws currently permit voting by proxy. Note: NASRA is incorporated under the laws of the state of Minnesota.)

There may be occasions when it is necessary for NASRA to conduct business other than at the annual business meeting. Minnesota Statute § 317A.447 allows members to take action without a meeting, by ballot, if NASRA delivers a ballot to every member entitled to vote on the matter. NASRA may deliver the ballot to a member by electronic communication, if the member has provided NASRA with consent to receive notices by electronic communication (see Minnesota Statute § 317A.450). **Please indicate whether or not you (the designated voting member) consent to receive notices, communications, and information regarding NASRA business by electronic communications.**
